The NTT is an indigenous, philanthropic organization that supports social justice, human rights, and peace and reconciliation initiatives. The NTT was established in 2001, two years after the assassination of Dr. Neelan Tiruchelvam; constitutional scholar, lawyer, activist and politician. Dr. Tiruchelvam sought to engage policymakers as well as the wider public towards his vision of a peaceful Sri Lanka, in an enabling environment of mutual trust and respect, which would transcend all political, socio-economic and cultural barriers. Over the years, the programmes which have been supported by the Trust have evolved, in keeping with the ever changing needs of the communities that it works with.

The Trust's vision is the establishment and protection of a just, equitable and peaceful society. Its mission is to collectively promote peace, reconciliation and human rights, sharing responsibility, resources and risks through strategic partnerships with civil society, donors and the public sector, business communities, the diaspora and the academia.

Promoting Good Governance, Democracy and Institution Building

Good governance signifies an adherence to processes and rules that enables all citizens in a state to participate in the democratic process, whether directly or through their elected representatives. Similarly, in the non-profit sector, we believe that good governance is achieved when organizations adopt transparent procedures to manage its human resources, activities and finances.

NTT supports any effort that promotes democracy, and the inclusion of all communities, individuals and groups in the democratic process. Going beyond the strict confines of grant making, the Trust supports initiatives related to institution building for CBOs, NGOs and CSOs. Capacity building, technical assistance, provision of seed or core funding to support new and emerging organizations that are doing innovative work in all areas related to our own thematic areas are supported in order to ensure that the right systems are in place for organizations to carry out their activities.

- 23 long term observers were deployed in eight districts, from the date of nomination until one week after the elections, to ensure a free and fair election.
- 150 observers were deployed at polling stations on election day.
- 100 persons were trained as mobile observers covering all 25 administrative districts, and 25 mobile teams were deployed on election day.

PAFFREL is the first citizen-based election watch to have been established in Sri Lanka. PAFFREL motivates and encourages voters to exercise their basic democratic rights, to cast their vote at all elections, and promotes community efforts to prevent violence and malpractice before, during and after elections. Through this project PAFFREL aimed to reduce election related violence and violations, and ensure credible local government elections in 2018, with a level playing field for all political parties and candidates. Particular focus was placed on preventing discrimination, abuse and violence against women candidates.

Promoting and Achieving Social Justice

Social justice is an underlying principle for peaceful and prosperous coexistence within and among communities. Social justice is advanced when the barriers that confront people – because of gender, age, race, ethnicity, religion, culture or disability - have been removed. Under this thematic area NTT promotes and supports activities that protect the rights of marginalized communities, and empower those communities through economic rights. NTT works with partners to support initiatives that seek to enhance the status of vulnerable groups including plantation workers, people with disabilities, migrant workers, and marginalised communities, to promote their political, economic and socio-cultural rights.

Close to a decade after the end of the conflict in Sri Lanka, people are eager to establish a sense of normalcy in their lives; none more so than those hailing from the areas which were directly affected by the war. However, the trickle-down benefits of macroeconomic development often fail to reach beneficiaries at the community and village levels quickly enough. It is essential that people in these communities have access to employment and skill building opportunities. NTT collaborates with its partners to support activities that benefit the community as a whole. The Trust applies a rights based approach, which includes a conflict resolution framework, when implementing such programmes.

- Prosthetic limbs and arms, and physiotherapy services were provided to 75 amputees from war affected, low income families.
- Beneficiaries attended training programs on entrepreneurship and personal development, to motivate and encourage them challenge the dependency mind-set.

FH Sri Lanka, established in 1971, is a facil-Vity which provides prosthetic and orthotic devices and rehabilitation services to physically challenged people from all over the island, enabling them to live full and productive lives. This project aimed to provide prosthetic limbs to amputees who were unable to afford it, and to provide the best physiotherapy services to help the recipient to use the artificial limb to its maximum potential. Training in life skills was provided to improve the recipients' quality of life, and enhance income generation potential.

As NN was founded in 2007 and collaborates with government, NGOs and civil society organizations to address issues faced by Persons with Disabilities (PWD). ASNN aims to ensure equal and sufficient educational, medical and social services for children with special needs. This project focused on preparing advocacy documents to advocate for the rights and services of PWDs. Special focus was given to developing the capacity of educational institutions, and enhancing the quality of services provided to PWDs. The project trained service providers to handle and manage gender related issues of person with disabilities.









Promoting and Protecting the Rights of Women

TTT supports programmes that increase the ability of women $\mathbf{1}$ to claim and exercise their rights. While adopting a national level focus, the Trust is well aware that the majority of women who were affected by the armed conflict continue to face considerable challenges in rebuilding their lives. Particular subsets such as women headed households are most vulnerable. Conflict affected women have specific needs and concerns that need to be addressed urgently.

While striving to maintain a holistic approach in its strategy, the Trust remains grounded within the rights framework that will address factors that aggravate the vulnerabilities of marginalized women, and contribute to their exploitation. Programmes that address these vulnerabilities, such as those that increase the economic security of women through the provision of livelihood opportunities are supported through the Trust.

The armed conflict has also eroded the hierarchies that once existed, and provides opportunities to hitherto marginalized groups. At the same time there are societal level backlashes on attempts by women to challenge social norms and push social boundaries. NTT endeavors to work with such groups, with the aim of bringing about long term change, and increasing the space for women to participate in decision making processes at all levels of society. NTT also supports initiatives that seek to promote women leaders through training, exchange programmes and fellowships.

RESULTS

- 92 office bearers from selected women's groups participated in interactive dialogue sessions.
 Seven women were selected to receive start up support and training to engage in backyard poultry farming.
- An existing milling facility was upgraded to increase the productivity and income of the women's group in the Amuthavalli plantation. Several women use the milling facility on a roster basis while others engage in packaging, distribution and collection.

Through this project the UFDF aimed to improve the living conditions of women and youth in the estate sector. Activities were designed to facilitate a vulnerable group of women to access income oriented livelihood opportunities. Peer leaders were promoted to support young women and girls to safeguard and upgrade their rights, and the project strived to create a protective community network for such groups with the involvements of key decision makers.

New Arrow was established with the aim of empowering women and reducing violence against women in the Batticaloa District. Women and girls in this area were directly affected during and after 30 years of conflict, and require need special support to overcome their challenges. This project aimed to create a non-violent society through enhanced self-confidence and education among rural women and youth.

The NSDF implements programs related to reproductive health, vocational training, income generation, child rights, community development and women's empowerment in the plantation sector. This project aimed to provide knowledge, and strengthen women to overcome the challenges they face in today's environment.

- 144 women formed small groups with financial management committees.
- 125 women participated in financial management workshops.
- 113 women participated in workshops on reproductive health.
- 84 women participated in workshops on women's rights.
- Vegetable seeds, home gardening tools and training was provided to 150 women.

Support could be in areas such as participation in decision making processes and peace building efforts, promoting democratic values and equal participation of male and female youth in fora, dialogues, mooting, exchange programmes, fellowships and internships.

The CCH is a non - profit, non-religious and non-political consultancy organization, committed to supporting disadvantaged children and youth to develop their personality, skills, moral choices and career potential by creating and offering multi-disciplinary resources and services. This project aimed to increase employability among youth in resettled villages in Jaffna through skill and enterprise development.



The Neelan Tiruchelvam Memorial Lecture



The 18th annual memorial lecture marking the death anniversary of Dr. Neelan Tiruchelvam was held on Sunday 30th of July 2017 at the BMICH. The lecture, titled 'Forensic Architecture: Space and Violence in Palestine and Beyond,' was delivered by Professor Eyal Weizman, Professor of Spatial and Visual Cultures at Goldsmiths, University of London.

The lecture focused on the application of forensic architecture in places of conflict - such as Palestine and Pakistan - to critically evaluate the politics and aesthetics of contemporary forms of spatial investigation. Recognizing the importance of human rights work, Prof. Weizman stressed on how it should be able to make connections with local politics, situations and regional and universal aspirations, understand the complexity around such situations, and reach out to them. This, he explained was important in understanding what revolves around communities in struggle, and also gives room to identify some of the root causes of such struggles. He spoke of how human rights work should generate a global conversation undertaken by civil society, and also develop the politics of those who are governed by it, thereby forming political solidarity and a sense of common struggle across and beyond borders. Prof. Weizman spoke of how carefully researching a single event provides insight on the perpetuation of violence on a much larger scale. He encouraged the audience to look at the bigger picture of human rights, in relation to the planet, its conditions and how they tend to be interlinked.

The Sithie Tiruchelvam Women's Fellowship Program

The WFP initiative intends to build a cadre of women leaders who can effectively advocate on behalf of their communities, and increase community participation in decision-making that impacts them. The programme is part of NTT's larger focus area to build capacity at an organizational, community and individual level.

Six women from the Northern and Eastern Provinces were selected to participate in the WFP programme. Priority is given to young women, in the 30 -35 age group, and in the selection process NTT looks for women who are able to commit themselves, and have a strong passion towards promoting human rights and gender justice.

The core objectives of the WFP are: (i) to develop a feminist perspective on a range of issues related to rural development and reconstruction, with a special focus on women's rights and entitlements, (ii) to increase the ability of women to claim, protect and exercise their rights, (iii) to strengthen the capacity of the staff from various NGOs, human rights and women's rights groups, and other civil society organizations and individuals, (iv) to build a better understanding on gender equality, women's development and social justice, (v) to strengthen sustainable resource management, (vi) to improve peace of mind, and educate women on improving health and wellbeing.

The 2017/18 programme was divided into three phases, and included both local and international exposure - phase 2 of the programme was conducted in Madurai, India, with five additional participants from Tamil Nadu.

INDEPENDENT AUDITOR'S REPORT
TO THE BOARD OF TRUSTEES OF NEELAN TIRUCHELVAM TRUST

Report on the audit of the Financial Statements

Opinion

We have audited the accompanying Financial Statements of Neelan Tiruchelvam Trust ("the Trust") which comprise the Statement of Financial Position as at 31 March 2018, and Statement of Comprehensive Income, Statement of Changes in Reserves and Statement of Cash Flows for the year then ended, and a summary of significant accounting policies and other explanatory notes set out on pages 06 to 19.

In our opinion, the financial statements give a true and fair view of the financial position of the Neelan Tiruchelvam Trust as at 31 March 2018, and of its financial performance and cash flows for the year then ended in accordance with Sri Lanka Statement of Recommended Practice for Not-for-Profit Organizations (Including Non-Governmental Organization) (SL SoRP-NPO's [including NGO's]) issued by the Institute of Chartered Accountants of Sri Lanka.

Basis for opinion

We conducted our audit in accordance with Sri Lanka Auditing Standards (SLAuSs). Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the Trust in accordance with the Code of Ethics issued by CA Sri Lanka (Code of Ethics) and we have fulfilled our other ethical responsibilities in accordance with the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Board and those charged with governance for the financial statements

Board of Trustees ("the Board") is responsible for the preparation of financial statements that give a true and fair view in accordance with Sri Lanka Statement of Recommended Practice for Not-for-Profit Organizations (Including Non-Governmental Organization) (SL SoRP-NPO's [including NGO's]) issued by the Institute of Chartered Accountants of Sri Lanka, and for such internal control as Board determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, Board is responsible for assessing the Trust's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless Board either intends to liquidate the Trust or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Trust's financial reporting process.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SLAuSs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Building a better working world

As part of an audit in accordance with SLAuSs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due
 to fraud or error, design and perform audit procedures responsive to those risks, and obtain
 audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of
 not detecting a material misstatement resulting from fraud is higher than for one resulting from
 error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the
 override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit
 procedures that are appropriate in the circumstances, but not for the purpose of expressing an
 opinion on the effectiveness of the Trust's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
